Subject:- Grant of recognition from classes I to X without  
grant-in-aid.

Sir,

With reference to the correspondence resting with your letter No. D. E/76-77/719 dated 17.12.1976 on the subject cited above, I am directed to inform you that the Director of Education, Delhi has been pleased to grant recognition to your school from classes I to X without grant-in-aid up to 30.4.1977 subject to the fulfilment of the following conditions:-

1. The admission should be opened for all without any caste, creed and religion.
2. The school premises should not be utilised for commercial, residential, communal, political or non-educational activities of any kind whatsoever.
3. The instructions issued by the Department from time to time should be followed scrupulously.
4. All records pertaining to the school should be opened for inspection for the Department.
5. Nursery classes may be removed by 28.2.1977.
6. 25% students may be admitted in the school from the weaker Section of the Society and 15% of them may be allowed full fee concession and 10% half fee concession.
7. Only trained and fully qualified teachers/staff within the prescribed age limit should be appointed in the school. The unqualified and overage staff may be replaced by 28.2.1977.
8. Service agreement in respect of teachers and other employees should be made available to this office within three months from the date of appointment.

9. The scales of pay and allowances, medical facilities and other benefits of the employees should not be less than those of the employees of the corresponding status in schools run by the Delhi Administration.
10. Students of class VIII of recognised schools should be admitted in class IX only.
11. The school should follow the approved courses of instructions and syllabus prescribed by the appropriate authority.
12. A sum of Rs. 5000/- should be spent on the purchase of library books.
13. The scheme of management may be submitted by 28.2.1977.
14. If some students are desirous to take instruction in Hindi, arrangements for the same should also be made.
15. The fee should not be enhanced without the prior approval of the Department.
