#### AFFIDAVIT

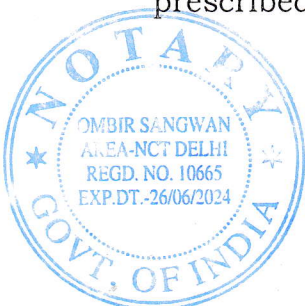
